In consideration of being allowed to enter or use the Tactical Training Center L.L.C. (hereafter identified as TTC) facilities; including but not limited to the firearms range, rental firearms, instruction or events, I hereby agree to each of the following terms and conditions of this agreement and I have truthfully answered each question; and by circling a response to each question, I indicate that each question answered has been read, understood and answered truthfully by me. Additionally, in order to utilize the TTC facilities or rent a firearm you must not be prohibited by any of the following disqualifiers:

As a non-NJ resident you must be 21 years of age (18 for long guns), with valid governmental photo identification to use the Tactical Training Center, L.L.C. (hereafter identified as TTC) facilities with your own firearms. To rent TTC firearms as a non-resident you must be accompanied by another or possess a Concealed Carry Permit (CCP) from your state of residence or possess a NJ Non-Resident Firearms Identification Card (FID).

As a NJ resident to rent (or use) TTC owned firearms you must be 21 years of age (18 for long guns), possess a NJ FID card, be accompanied by someone who possesses a NJ FID, or be part of a TTC training session or class instructed by TTC authorized instructors.

In consideration for being given access to the TTC facility and/or equipment, and/or programs or events, the undersigned, for himself or herself and his or her heirs, executors and administrators, **releases, waives, discharges and covenants not to sue** the TTC, and each of its members, officers, managers, employees and agents, for any and all liability, claims, demands, actions and causes of action whatsoever for personal injury or property damage arising out of the use of the equipment and/or facilities of TTC, or arising from the negligence of TTC, and agrees to hold TTC free, clear and harmless and indemnify TTC from and against any responsibility for any and all claims, demands, actions and causes of action for personal injury or property damage, loss or injury, including death, that may be sustained by the undersigned, whether caused by the negligence of TTC or otherwise, arising out of all such use of TTC's property and facilities. ***I acknowledge that as a condition of TTC allowing me to access the TTC facilities and/or equipment, and/or programs or events, I will also be required to watch a safety video and read, sign and deliver to the TTC the Adult Release, Assumption of Risk and Indemnity Agreement (Shooter's Waiver).*** The undersigned agrees to be held financially responsible for any willful act of destruction to any part of the TTC facilities or equipment. All firearms rented from TTC must use ammunition purchased from TTC.

Finally, I state that I am familiar with the safe use and operation of any firearm rented, to include loading/unloading, function, recoil management and any other safety issues. I acknowledge that it is my responsibility to inform TTC staff if I have questions about the use of any rental firearm prior to firing such firearm. I acknowledge that this form must be completed each time I use the range as an out of state shooter or to rent any TTC owned firearms (resident and/ or non-resident).
