In consideration for being given access to the TTC facility and/or equipment, the undersigned, for himself or herself and his or her heirs, executors and administrators, **RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** TTC, and each of its members, officers, managers, employees and agents, for any and all liability, claims, demands, actions and causes of action whatsoever for personal injury or property damage arising out of the use of the equipment and/or facilities of TTC, or arising from the negligence of TTC, and agrees to hold TTC free, clear and harmless and indemnify TTC from and against any responsibility for any and all claims, demands, actions and causes of action for personal injury or property damage, loss or injury, including death, that may be sustained by the undersigned, whether caused by the negligence of TTC or otherwise, arising out of all such use of TTC's property and facility. I acknowledge that as a condition to TTC allowing me to access the TTC facility and/or equipment, I will also be resigned to sign and deliver to TTC the Adult Release, Assumption of Risk and Indemnity Agreement.

TTC Range Rules

1. The muzzle of all firearms must be kept pointed downrange (muzzle pointed at the back stop) at all times. If leaving the range temporarily, leave all firearms on the firing line and clear them by unloading with the action left open, muzzle pointing downrange with the ejection port up, with a chamber flag inserted. Report your absence to the Range Safety Officer (RSO).
2. Always keep your finger off the trigger and indexed along the frame of the firearm until ready to shoot.
3. Always keep the action open and the firearm unloaded until ready to shoot.
4. Know how to operate the firearm safely. If unsure, consult with a Range Safety Officer.
5. No one is allowed on the range under the influence of alcohol or other substances (prescription or otherwise) that may negatively affect alertness/safe shooting capabilities.
6. Except law enforcement officers, no loaded firearms are to enter or exit the building or range area. Magazines may be loaded prior to entering or exiting the building/range, however they must be carried separate from the firearm(s). No firearms are permitted in the retail area without being unloaded and in a closed and fastened case or container. You are responsible for complying with all applicable laws while at our facility and when transporting firearms.
7. On any "Cease Fire" command, immediately bench the firearm, muzzle downrange and step behind the red line away from the firearm. Remain there until directed further by range staff.
8. No uncased firearms or ammunition is permitted in the classroom(s), VIP lounge or bathrooms.
9. Any firearms or ammunition found to be unsafe or unserviceable will not be allowed to be utilized. All firearms and equipment are subject to inspection and approval prior to or during use on the range. Only properly functioning firearms and equipment should be used at the range. Firearms shall remain in the port once uncased.
10. Two shooters only are allowed per port. One additional shooter/observer may remain behind the redline at the discretion of the RSO. All persons entering the range will be charged accordingly and must complete appropriate waiver forms before entering the range area.
11. Appropriate Eye and Ear protection must be worn at all times on the range. Electronic ear muffs and "double muffing" (plugs and muffs) are encouraged.
12. Attire: Range appropriate clothing such as sneakers, skid resistant shoes, long sleeve shirts and ball caps are encouraged. Wearing open toed shoes and loose collared shirts are discouraged.
13. Shooting at anything other than your own target is strictly prohibited. Targets must be placed on TTC target hangers and made of paper or plastic.
14. Wearing or drawing from a holster is only permitted by approved law enforcement or approved customers who have completed the appropriate training (i.e. TTC Holster Draw training classes).
15. Use only the correct ammunition for your specific firearm. All ammunition is subject to inspection and approval. Shotguns must shoot slugs only. Birdshot, trap loads or buckshot may be permitted with prior approval. No armor piercing, tracer or incendiary ammunition is permitted. This includes military black-tipped ammo, green-tipped steel core or bi-metal (steel) ammunition. Steel cased (casing not projectile) ammunition is permitted.
16. If a misfire, hang-fire or other unfamiliar malfunction occurs, keep the firearm pointed downrange, bench the firearm if appropriate and signal the RSO. Do not leave the firing port with a loaded or jammed firearm.
17. TTC and its staff shall not be held liable for any damages incurred from the use of ammunition sold at TTC. Customer will resolve any issues with the manufacturer of the product. Customers damaging TTC range property may be charged for repair/replacement.
18. All firing must be controlled. Fast or rapid fire may be allowed for approved shooters.
19. All shooters must comply with the directions of the RSO. Failure to do so will result in expulsion from the range without any refunds. The RSO's are here for your and everyone's safety.
20. Report any unsafe conduct observed to the RSO's immediately.
21. Any brass to be removed from the range must be marked by the shooter before firing. Please notify the RSO before firing that you wish to collect your brass.
22. Only ammunition purchased from TTC is permitted in TTC rental firearms.
23. Expectant mothers are not allowed on the range at any time for health reasons.
24. Disassembly of firearms for the purpose of cleaning in the port is not allowed.
25. No paid or professional training by other than TTC personnel is allowed on the range.
26. Any reckless behavior will result in immediate expulsion from the range and premises without refund/exception.

I acknowledge that I have read the above Range Rules in their entirety and I agree to abide by all Range Rules.
