

TTC RANGE SAFETY RULES

- 1. The muzzle of all firearms must be kept pointed downrange (muzzle pointed at the back stop) at all times.
2. If leaving the range temporarily, leave all firearms on the firing line and clear them by unloading with the action left open, muzzle pointing downrange with the ejection port up, with a chamber flag inserted. Report your absence to the Range Safety Officer (RSO).
3. Always keep your finger off the trigger and indexed along the frame of the firearm until ready to shoot.
4. Always keep the action open and the firearm unloaded until ready to shoot.
5. Know how to operate the firearm safely. If unsure, SCHEDULE A LESSON.
6. No one is allowed on the range under the influence of alcohol or other substances (prescription or otherwise) that may negatively affect alertness/safe shooting capabilities.
7. Except Law Enforcement Officers and New Jersey Concealed Carry permit holders, no loaded firearms are to enter or exit the building or range area. If you possess a NJ CCW and are TTC Holster Qualified, the handgun must remain holstered and concealed unless you are actively shooting in a Port. In the retail area, no firearms are permitted in the retail area unless they are holstered and concealed, or unloaded and cased in a closed and fastened case or container. Unloaded means empty chamber and no magazine in the firearm. You are responsible for complying with all applicable laws while at our facility and when transporting firearms.
8. On any "Cease Fire" command, immediately bench the firearm, muzzle downrange and step behind the red line away from the firearm. Remain there until directed further by range staff.
9. No uncased firearms or ammunition is permitted in the classroom(s), VIP lounge or bathrooms.
10. Any firearms or ammunition found to be unsafe or unserviceable will not be allowed to be utilized. All firearms and equipment are subject to inspection and approval prior to or during use on the range.
11. Two shooters only are allowed per port. One additional shooter/observer may remain behind the redline at the discretion of the RSO. All persons entering the range will be charged accordingly and must complete appropriate waiver forms before entering the range area.
12. Appropriate Eye and Ear protection must be worn at all times on the range. Electronic ear muffs and "double muffing" (plugs and muffs) are encouraged.
13. Attire: Range appropriate clothing such as sneakers, skid resistant shoes, long sleeve shirts and ball caps are encouraged. Wearing open toed shoes and loose collared shirts are discouraged.
14. Shooting at anything other than your own target is strictly prohibited. Targets must be placed on TTC target hangers and made of paper or plastic. The target must be positioned so that the bullet impacts the backstop and not the ceiling or floor.
15. Wearing or drawing from a holster is only permitted by approved law enforcement or approved customers who have completed the appropriate training (i.e. TTC Holster Draw training classes).
16. Use only the correct ammunition for your specific firearm. All ammunition is subject to inspection and approval. Shotguns must shoot slugs only, unless prior permission was arranged for shot-shells. No armor piercing, tracer or incendiary ammunition is permitted. This includes military black-tipped ammo, green-tipped steel core or bi-metal (steel) ammunition. Steel cased (casing not projectile) ammunition is permitted.
17. If a misfire, hang-fire or other unfamiliar malfunction occurs, keep the firearm pointed downrange, bench the firearm if appropriate and signal the RSO. Do not leave the firing port with a loaded or jammed firearm.
18. TTC and its staff shall not be held liable for any damages incurred from the use of ammunition sold at TTC. Customer will resolve any issues with the manufacturer of the product. Customers damaging TTC range property may be charged for repair/replacement.
19. All firing must be controlled. Fast or rapid fire may be allowed for approved shooters.
20. All shooters must comply with the directions of the RSO. Failure to do so will result in expulsion from the range without any refunds. The RSO's are here for your and everyone's safety.
21. Report any unsafe conduct observed to the RSO's immediately.
22. Any brass to be removed from the range must be marked by the shooter before firing. Please notify the RSO before firing you wish to collect your brass.
23. Only ammunition purchased from TTC is permitted in TTC rental firearms.
24. Expectant mothers are not allowed on the range at any time for health reasons.
25. Disassembly of firearms for the purpose of cleaning in the port is not allowed.
26. Disassembly of TTC rental firearms is strictly prohibited. Leave firearm in the port and notify an RSO.
27. No paid or professional training by other than TTC personnel is allowed on the range.
28. Any reckless behavior will result in immediate expulsion from the range and premises without refund/exception.

Anyone who wishes to shoot in this facility, whether using their own firearm, a Tactical Training Center, LLC ("TTC") rental firearm, or wishes to be present in the firearms range, MUST fill out this form in its entirety. All information supplied will be kept strictly confidential, not distributed or made available to others for any purpose, and is for the sole use by the TTC. This is for the sole use by TTC to properly identify the user, and to document their previous firearm's experience. This is necessary to best insure the safety of all range users. In consideration for being given access to the TTC facility and/or equipment, the undersigned, for himself or herself and his or her heirs, executors and administrators, releases waives, discharges and covenants not to sue TTC and each of its members, officers, managers, employees, and agents for any and all claims, demands, actions, and causes of action for personal injury and property damage, loss or injury, including death, that may be sustained by the undersigned, whether caused by the negligence of the Releases or otherwise, arising out of all such use. I acknowledge that as a condition to TTC allowing me to access the TTC facility and/or equipment, I will also be required to sign, agree to and deliver to TTC the Adult Release, Assumption of Risk and Indemnity Agreement.

The undersigned agrees to be held financially responsible for any willful act of destruction to any part of the TTC facility and to any TTC equipment, beyond normal wear and tear.

In consideration of being allowed to enter or use the facilities, including but not limited to the shooting ranges (all of which are hereinafter referred to as the "Facilities" or "TTC") and participate in the activities of the TTC Range located at 10A Minneakoning Rd. Flemington, N.J. 08822, I hereby agree to each of the following terms and conditions of this agreement and I have initialed each as having been read and understood by me:

### ADULT RELEASE, ASSUMPTION OR RISK AND INDEMNITY AGREEMENT

1. I have read the TTC range rules, a copy has been given to me by TTC. I understand the Range Rules may be amended from time to time (either in writing or orally) and that I am responsible for reviewing the posted Range Rules when I use the TTC facilities. I verify that, before using the TTC Facilities, I either have watched or will watch the TTC safety presentation. I agree to obey and comply with the range rules, general policies of operation and administration of TTC. Initials \_\_\_\_\_
2. I am familiar with and understand the operation of each firearm (rifle, handgun, shotgun) which I will use at TTC. The word "operation" includes the safe handling, loading and unloading procedure, and safety mechanisms and features of each firearm. Initials \_\_\_\_\_
3. I understand the range commands "cease fire" and "clear firearms" and will comply with the RSO's commands and directions. Initials \_\_\_\_\_
4. I understand that TTC suggests the use of newly manufactured commercial ammunition at all times on TTC ranges. I accept full and complete responsibility for the inherent risk resulting from my own or anyone else's reloaded ammunition, including all responsibility for bodily injuries to myself and anyone else. I also agree to thoroughly check to be sure I am using the correct ammunition at all times. Initials \_\_\_\_\_
5. I agree that prior to participating in or observing any shooting activities, I will inspect the facilities, the range port, firearms and ammunition to be used and, if I believe anything is unsafe for any reason, I will so advise a Range Safety Officer and will leave the unsafe portion of the facility immediately. 6. I acknowledge and fully understand that I and all others engaged in shooting, coaching, observing or training with firearms at TTC will be engaged in activities that involve inherent risks of serious bodily injury including disability or death and severe social and economic losses which might result from my actions or inaction or the actions of others: **such causes of risks include but are not limited to:**
  - a. My failure to abide by firearms safety rules or to properly handle or use firearms or ammunition; Initials \_\_\_\_\_
  - b. The failure of others to abide by firearms safety rules or to properly handle or use firearms or ammunition; Initials \_\_\_\_\_
  - c. The characteristics, including the design, manufacturing or other defects, of any firearm or ammunition being used by myself or others at TTC. Initials \_\_\_\_\_
  - d. The characteristics, including the design, construction, and maintenance, of TTC facilities including, but not limited to, the multiple firing point ranges: Initials \_\_\_\_\_
  - e. The inability of TTC personnel (including Range Safety Officers) to, at all time, monitor or supervise TTC members, their guests, hourly fee users and others using the TTC facilities including said ranges. Initials \_\_\_\_\_
7. I recognize that I may be expelled from TTC for violation of the Range Rules or for behavior deemed unsafe by TTC personnel. Decisions regarding expulsion are final and no refunds will be given. Initials \_\_\_\_\_
8. I accept full responsibility for any damage or destruction I cause to TTC property, whether accidental, negligent, willful or otherwise. TTC property includes, but is not limited to, the facility, range equipment, target frames, target supports or mechanisms, firearms, signs, and all equipment, electrical and otherwise. TTC reserves the right to recover from me a reasonable charge for any such damage and is entitled to recover its costs, including reasonable attorney's fees, incurred in bringing any claim for such damages. 9. On behalf of myself, my heirs, executors, administrators and assigns, I hereby assume all risk of personal injury, disability or death. The word "damages" includes, but is not limited to, the incurring of any physical and emotional injury of any kind, loss of physical function, ability or capacity, medical expenses, lost wages or income, loss of consortium and any other compensatory damage. 10. On behalf of myself, my heirs, executors, administrators and assigns, I hereby waive, release and discharge TTC, LLC and their affiliates, and each of their officers, directors, owners (members), managers, employees, agents, successor and assigns ("Released Parties") from any and all claims, demands, actions, or lawsuits seeking damages on account of any personal injury, disability or death occurring to myself or anyone else, caused in whole or in part or alleged to be so caused by the negligence of any of the released Parties or caused by anyone else. 11. On behalf of myself, my heirs, executors, administrators and assigns, I hereby agree to indemnify and defend the Released Parties from any and all claims, demands, actions or lawsuits for any personal injury, disability or death occurring to myself or any other person which result entirely or in part from the actions, failure to act, or negligence of myself, my guests or minors for whom I am responsible. 12. I agree that this Adult Release, Assumption of Risk and Indemnity shall be interpreted according to New Jersey law and that any dispute shall be resolved exclusively in the federal or state courts located in the State of New Jersey. Initials \_\_\_\_\_
13. Membership in the TTC facility will be available to persons who are legally able to possess a firearm. TTC Members must be in compliance at all times with all federal, state and local laws and regulations concerning ownership and handling of firearms. Memberships will be granted, and may be revoked, at the sole discretion of TTC. Initials \_\_\_\_\_
14. The Tactical Training Center of New Jersey is a privately owned facility. As such, TTC reserves the right to refuse, suspend or revoke service, access to the facility or access to classroom instruction, to any individual or individuals, at any time. The TTC will comply with all state and federal laws. Initials \_\_\_\_\_
15. I certify the following is true: (1) I am not currently and have never been the subject of a criminal, civil or family court proceeding or any other proceeding that prevents me from legally owning, handling or possessing firearms, as defined, under New Jersey or Federal Law; (2) that I can lawfully own, handle and possess a firearm: and, (3) that all information given in the application is true and correct to the best of my knowledge. 16. I certify that I am NOT an unlawful user of, impaired or addicted to, or under the influence of alcohol, marijuana or any depressant, stimulant, or narcotic drug or any other controlled dangerous substance. Initials \_\_\_\_\_
17. I certify that I do NOT possess any physical, mental, visual, or auditory impairment that would prevent me from safely operating a firearm. Initials \_\_\_\_\_
18. I certify that I am not presently and have never been a member of any organization which advocates or approves the commission of acts of force and violence, either to overthrow the Government of the United States or of this State, or which seeks to deny others of their rights under the Constitution of either the United States or the State of New Jersey. 19. In the event I bring a minor to TTC, the attached Guardian's release, Assumption of Risk and Indemnity Agreement has been signed by the minor's legal guardian. Initials \_\_\_\_\_
20. I recognize the safety of everyone at TTC is my responsibility and I agree not to cause harm to myself or others at TTC. Initials \_\_\_\_\_
21. I agree to immediately report any death, injury, property damage, whether intentional, reckless, or negligent to the TTC staff. I also agree to immediately report any reckless, negligent or otherwise dangerous behavior to the TTC staff. Initials \_\_\_\_\_
